- 1. Eric provided a recap on the Ohio Stormwater Conference, held last week in Sandusky, Ohio. Jim, Mary Helen, and Shawn also attended and provided comments.
- 2. Storm water management resolutions: Eric noted the Steering Committee is still working on edits to the IDDE and construction/post-construction resolutions.
 - a. Mary Helen noted the need to include charity car washes as an exemption in the IDDE resolution.
 - b. Shawn suggested a final crossread between the proposed resolutions and the current OhioEPA permit as a check.
- 3. Annual good housekeeping training: Eric noted this training will be held as the next SWTF meeting. Location TBD.
 - a. There was a question regarding PARTA's status within the MS4 and if they should be invited to the training session.
